## 1. SERVICES:

Jellybean Media Services agrees to provide the following services ("Services") to the client:

  - Priority customer support.
- c. **Annual Hosting Fee:** Subsequent **annual** library hosting fee billed at **\$200**.

## 2. PAYMENT:

The client agrees to pay Long Video Services / Jellybean Media Services the amounts specified for the Services provided. Payments shall be made in accordance with the payment terms outlined in the corresponding invoices.

## 3. LINK TO LIBRARY:

Jellybean Media Services will provide the organization with a unique link to their customized online book library, which can be embedded on their website.

## 4. TERM:
